

NIVEA MEN BOOTS FATHER'S DAY PROMOTION 2022 FULL UK TERMS & CONDITIONS

- 3. NI Entry: No purchase necessary.
- 4. Text NIVEAMEN22 to 88802 UK mobile required. Standard network rates apply.
 - All entrants will receive a confirmation text confirming that their entry has been successful and sharing a link to the Promotional Terms and Conditions and Privacy Policy.
