# Medication administration systems

- Free, easy-to-use medication administration systems, with full staff training and ongoing advice and audits from our expert pharmacy team
- Free prescription management from collection to delivery and customised service level agreements to meet your needs
- Computer-generated medication records to help ensure there is a clear audit trail for the medication management process, including receipt, administration and return of all medication
- Customised service level agreements - meaning that medications are supplied to meet your needs, whether traditionally dispensed or individually sealing in our market-leading Monitored Dosage System, racked by individual or by home
- The Boots Monitored Dosage System delivers a 4-week supply of each individual patient's tablets and capsules in blister packs, to be taken at the time and date shown. The pill packs are colourcoded for the time of day so the carer can quickly tell when the medication should be administered

# **Care of Medicines training**

- Medicines management training accredited by the College of Pharmacy Practice

#### Pharmacy advice visits

- Pharmacy advice visits are designed to improve the quality of pharmaceutical care provided by the homes
- The service is provided by a registered pharmacist with a special interest in care homes; or by a registered pharmacy technician who has the necessary training
- The visit typically takes 1-2 hours and is primarily designed to review the medicines management process within the home.
  The findings are discussed with the home manager, with any agreed next steps to support the home

## Midnight pharmacies

- Boots have over 70 pharmacies around the country open until midnight

# Medicine check-ups

- Medicines Check-Ups\* (MCUs) are a free in store NHS service (available in England and Wales) to support patients with their medicines
- They are designed to ensure patients get the best from their medicines and identify medicines that are no longer required, or not currently being used effectively
- Patients taking more than one medicine or suffering from a long-term illness, who have had their prescriptions dispensed from the same pharmacy for the last 3 months are eligible for an MCU.
- Each of these patients is eligible for an MCU every 12 months

\* This NHS service is also referred to as Medicines Use Review (MURs)





## Eye care and Hearing care

- Boots Opticians currently operates a Domiciliary service in Glasgow, Edinburgh, Manchester and Wakefield and the surrounding areas
- We offer eye and hearing exams carried out by Optometrists and Hearing Aid Audiologists who will visit the patient free of charge and we also offer an aftercare service. The eye exam may be charged for if the person does not qualify under current NHS rules
- We will visit anyone in the areas listed above who is housebound and unable to get to a local practice.
  This includes people in care homes, nursing homes, assisted living accommodation and individuals in their own homes
- Eye exams are funded by the NHS in the UK if patients are aged 60 and over or qualify under other NHS rules (all eye exams are NHS funded in Scotland). Spectacles can be NHS funded depending on needs
- Boots Opticians follows the Code of Practice for Domiciliary Eyecare as provided by the Federation of Ophthalmic and Dispensing Opticians
